CMA ADVOCACY UPDATE

The CMA is actively working to influence government on the proposed tax changes. We have retained one of Ottawa's top ranking strategy groups to supplement our internal government relations activities. One of the central pieces of our advocacy is our submission to government on October 2. We are commissioning an in-depth analysis from the Conference Board of Canada on the economic footprint of medical practices, as well as working with tax experts and MD Financial Management. In addition, we are working with organizations and associations who represent small business operators. This will facilitate the exchange of technical information and bring the collective weight of all affected parties to the government's attention.

85,000 MEMBERS NEEDED TO INFLUENCE GOVERNMENT

One of the most influential tools we have at the CMA is our membership. CMA President Dr. Granger Avery issued a [message to all members](#) this week, asking you to write, call, and meet with your MP, MPPs, and MLAs. Elected officials need to hear how these changes will affect your practice. You can also [send a letter to your MP](#) to make your voice heard.

MPs ARE IN THEIR RIDINGS — PLAN TO MEET WITH THEM

MPs are in their riding in August, hosting social events and scheduling constituency meetings. We encourage you to connect directly with your MPs to make them aware of the anticipated impact.
